# Deputy Chief's Report

- Reviewed submitted report.
- The state is in the beginning stages of the pedestrian bridge which will be on the west side of the locks.
- FDIC is August 8/2 7/2021.
- Will need to pay to replace a mailbox that was damaged at Ogee Trail.

# Assistant Chief's Report

- Reviewed submitted report.
- Drag races are canceled for the remainder of the year but will still put together crews in case they work out the problems and have the races back on.
- Squad is back in service. There was one concern from the Safety Officer. Due to the taller box on it the recommendation is to purchase a back-up camera for the squad.
   Motion by Commissioner Bird seconded by Commissioner Georgiev to purchase the camera from Amazon at a cost of \$105.99. 5 Yes 0 No
- Need 2 LED spotlights, one for the Deputy Chief's vehicle and one for the Assistant Chief's vehicle, at a cost of \$132.79 each for a total of \$265.58. Also, would like to purchase 46 new bailout system bags from Dival, one for each air pack, to replace having the equipment attached to gear which was causing wear and tear on the gear. The cost is \$33.98 per bag for a total of \$1,563.08. Motion by Commissioner Hammel seconded by Commissioner Georgiev to purchase the two LED spotlights at a cost of \$265.58 and the 46 bailout system bags at a cost of \$1,563.08.
- AC Medina inquired as to when do the budget planning meetings begin. Treasurer Kuhn indicated that we will begin the process of putting together the budget in July at which time we will look at the vehicle replacement schedule as well.
