 Discussed 2010 State Legislation regarding the Real Property Tax Law allowing Volunteer Firefighters and EMS to receive 10% off of their assessment. Monroe County is one of the counties now included. This is not an automatic; the school district, county, towns, village, and fire district must grant an exception under a resolution. Each taxing jurisdiction would need to adopt this by the end of February 2022. Eligible volunteers do not automatically receive this. 466.B of the Real Property Tax Law.
