Miscellaneous/Current Projects (cont'd):

The fuel tank issue at the Village DPW was resolved. Please remember to re-fuel the when the trucks are at or just above ¾ full.

The railroad crossing at Kenyon St. has re-opened.

Everything is now corrected with the New 233 and began training and clearing drivers. We hope to have it in service before next month.

We have asked for a line item for new pagers that will work with the new system. We are also waiting for the County's Tech Day so we can see the devices for the equipment to work with the CAD system. There will be more to come on that.

SCBA inspections are almost complete. Due to the fire on Wednesday Dival was unable to complete the inspections. They are hoping to be here Tuesday this week to finish the inspection. The quarterly air sampling of the SCBA Fill station was completed and sent in. The results will be posted soon. Compressor fill line hose #1 was cracked while filling bottles, Fletch Air came in during fire to emergently repair. Bill to be forthcoming.

Holley FD asked if we could loan them a Fire Extinguisher trainer for a program they will be doing for a business in town. I wanted to make sure that it would be alright.

Additional Information:

Our recruit class started on Tuesday evening with the Meet & Greet and there was a full class today 10/18.

Please remember to wipe down steering wheels, door handles, flat surfaces and other frequently touched surfaces with the wipes that are on all the apparatus.

We are still waiting for Varick FD to let us know about purchasing some of our older SCBA bottles. Holley FD has also been researching the possibly of purchasing used SCBA bottles as well. More to come.
