  - Reviewed the Advertisement for Bid

 Receive bids until 12/4/2025 at 2:00 pm with Bid Opening immediately following.

- Station 1 Roof Repair – Commissioner Koss indicated the roof work will begin and, if necessary, the materials may need to be put inside depending on the weather.
- Lowes has a 10 x 10 shed that they would like to donate. At this time, we do not have space for another shed. Possibly the Vets Club could use it.
- EMS Policy – Commissioner Georgiev reviewed the process. Indicated that they should submit the request to the Chief's Office for approval and once approved based on the budget that, if they fail the first time, then they do not have to pay for the class but, if they fail the class the second time, then the member pays for the class. DC Leggett indicated that a mentor will be assigned to a member who is planning to take the class. The EMS Policy should again be reviewed in the future.
- Commissioner Bird – working on the Preventative Maintenance Contract for the boilers and air conditioners.
- Women's Bunkroom (Bunkroom #2), will install solid doors.
- Commissioner Koss – The EMS Office needs ceiling work plus new cabling. Estimated cost approximately \$1,000.
